As per proceedings read from 3rd to 12th paper above, temporary promotions to the cadre of Deputy Tahsildars/Junior superintendent were given as per Rule 31(a) (i) of Part II K.S & S.S.R and subject to out come of the writ petitions. Rule 31(a) (i) of K.S & S.S.R envisages that where it is necessary in

the public interest owing to an emergency that which has arisen to fill immediately a vacancy in a post borne on the cadre of higher category in a service or class by promotion from a lower category and there would be undue delay in making such promotion in accordance with the rule, the Appointing Authority may promote a person otherwise than in accordance with the rules, temporarily. Also Rule 31(d) of K.S & S.S.R envisages that a person promoted under Rule 31(a) (i) shall not be regarded as a probationer in the higher category or be entitled by reason only of such promotion to any preferential claim to future promotions to such higher category.

In the judgment in WP(C).19076/08/U, the Hon'ble High Court of Kerala has directed the Principal Secretary to Government and the Commissioner of Land Revenue to prepare seniority lists of the feeder categories of HC/RI/VO based on the judgment in W.A.789/88 dated 21-03-1991 and W.A No. 162/91 dated 06-04-1995 as per which UDC / SVO, LDC / VA are identified as the feeder categories of the post of HC/RI/VO. Pursuant to these, seniority lists of the feeder categories of HC/RI/VO were revised and finalized vide proceedings read as 1st paper above.

It is made clear in the promotion proceedings itself that the promotions granted to the incumbents are on temporary basis and liable to be reviewed on the basis of seniority list of HC/RI/VO. Moreover it is also made clear that their promotion would not confer them any right other than the right of the emoluments attached to the post.

In the common judgment in WP(C).7711/09 and 29910/08 dated 27/09/2011 the Hon'ble High Court has observed that

"Depending on the seniority list so prepared, persons who got promotion contrary to the principles must be reverted and those who are denied promotion must be given promotion."

"The above promotions will be provisional subject to the result of Writ petition"

Based on the said judgment seniority list of HC/RI/VO for the period from 01/01/2006 to 31/12/2010 has been revised and finalized.

In the revised seniority lists for the period from 01.11.98 to 31.12.2005 and 01.01.2006 to 31.12.2010 published vide proceedings read as 1st paper

above, the following officers who were temporarily promoted to the cadre of Deputy Tahsildar / Junior Superintendent are reverted to the cadre of HC/RI/VO and posted in the Office/District Noted against their name since their rank in the revised seniority list is lowered.
