According to various judgments of the Honb'le High Court of Kerala, the seniority lists of Deputy Tahsildars/Junior Superintendents have been revised for the period from 01/01/1998 to 31/12/2008. Based on that revised seniority list, the select lists drawn earlier for the year 2003 to 2007, has also been revised by the Departmental Promotion Committee. The committee have also drawn the select lists for the year 2008 to 2012 and published vide papers 14 to 16 read above.

Consequently, a revised seniority list of Tahsildars were published vide 17th paper read above. Accordingly, the eligibility of the incumbents for Higher Grade in the cadre of Tahsildar has also been changed.

The 20% of the sanctioned strength in the cadre of Tahsildar up to 31-01-2011 are in Tahsildar Higher Grade and as per Government Order read as 13th paper above, the 25% of the sanctioned strength in the cadre of Tahsildar from 01-02-2011 are in Tahasildar Higher Grade.

In these circumstances, after considering the claims and objections on the provisional list published vide proceedings read as 18th paper above, I here by ordered to grant Higher Grade to the Tahsildars /Senior Superintendent included in the list appended with this proceedings w.e.f the dates noted against their name in column No. 07 in the scale of pay in column No. 08. The Senior Grade/Higher Grade granted to the officials vide proceedings 1 to 12 read above is hereby cancelled.
