The Ad-hoc Departmental Promotion Committee (Higher) for Revenue Department met on 30.11.2022 in the chamber of the Chairman for preparing the Select List of Tahsildars eligible for 'by transfer' appointment to the cadre of Deputy Collector under Kerala Civil Service (Executive), for the year 2022.

At the outset, the cases of the following officers who were superseded by the previous Ad-hoc DPC (H) meeting held on 06.06.2022 were reviewed.



**1. Sri. Sunilkumar.P (Rank No. 1366)**

The DPC (Higher) meetings held on 28.12.2020, 26.05.2021, 17.01.2022 & 06.06.2022 has decided to supersede Sri.Sunilkumar.P, considering the disciplinary proceedings pending against him and also on the gravity of the allegations.

Disciplinary action for major penalty initiated in file no.D1/62/18-Rev in connection with irregularities in Pokkuvaravu in Thakazhi Village was finalized by barring one annual increment with cumulative effect vide G.O.(Rt) No.3487/2021/RD dated 13.10.2021. Since the officer was in the currency period of punishment DPC has decided to supersede him. Now it is reported that the currency period of punishment imposed to him is over on 12.10.2022. Hence the DPC decided to include Sri.Sunilkumar.P (Rank No.1366) in the select list for the year 2022 and placed him as 25 (A) in between Smt.Radha.A (Sl. No.25 and Rank No.1801) and Sri.Vinod Raj (Sl. No.26 and Rank No.1802). His seniority in the select list for the year 2022 is fixed accordingly.

**2. Sri.Joy.P.P. (Rank No.1384)**

Sri.Joy.P.P was superseded by the last DPC on account of the currency period of punishment imposed and also due to pendency of disciplinary action.

(i) Sri.Joy.P.P was involved into a sting operation camera carried out by Mathrubhumi News Channel for identifying officers involved in the act of legalizing forged pattayam in Munnar. Pursuant to this the officer was transferred from the post. Disciplinary action was culminated in awarding 'censure' to the officer.

(ii) Disciplinary action for major penalty against Sri.Joy.P.P considered by the Government in connection with an enquiry report of Survey Vigilance Wing regarding the malpractices in files relating to LRM cases while he was officiating as Additional Tahsildar, Udumbanchola was finalized by barring three annual increments with cumulative effect as per G.O.(Rt) No.2751/2022/RD dated 23.06.2022. DPC observed that the officer is under the currency period of punishment. Hence DPC has unanimously decided to supersede Sri.Joy.P.P from including in the select list.

**3) Sri.Premalal M P (Rank No.1750)**

The officer was superseded by the last DPC on account of his non submission of Annual Confidential Report. Now it is reported that the officer has submitted the Annual Confidential Report



for the relevant period. Hence DPC decided to include Sri.Premlal.M.P (Rank No.1750) in the select list for the year 2022 and placed him as 25 (B) in between Sri.Sunilkumar.P (Sl. No.25 (A) and Rank No.1366) and Sri.Vinod Raj (Sl.No.26 and Rank No.1802). His seniority in the select list for the year 2022 is fixed accordingly.

**4) Sri.Suresh Babu K G (Rank No.1807)**

The officer was superseded by the last DPC on account of his non submission of Annual Confidential Report. It is noted that the the Officer has retired from service on 31.05.2022. Hence he need not be considered.

**As per the decision taken by DPC, Sri.Sunilkumar.P and Sri.Premlal.M.P are placed in the Select List of 2022 is given below;**
